



# **Conditions of Trade**

# Extended Trading Areas and Activation Areas

- 1. Businesses must apply for an Extended Footway Trading Area or Activation Areas by filling the form.
- 2. There is no fee to apply.
- 3. Extended Trading Area and Activation Area boundaries will be designated by Council.
- 4. The trading area must not impede or impact the designated emergency lane. The emergency lane is the centre driving lane of Bay St.
- 5. All waste and additional private bin collections is the responsibility of the business.
- 6. Businesses are responsible for maintaining a clean and tidy trading area, including managing spills and food scraps within the area.
- 7. Public liability insurance is the responsibility of the business. The business must have Public Liability Insurance for \$20 Million with Bayside Council as an interested party.
- 8. All trading infrastructure (tables, chairs, umbrellas etc) must be supplied by the business.
- 9. All footway trading infrastructure must be stored inside the business premises outside of the business' trading hours and must not obstruct public access.
- 10. Trading in the extended trading area or activation area must not begin until after the road is closed (5:00pm on Friday) and cease at 8pm on Sunday to allow for the road to reopen(the road reopens at 10:00pm on Sundays).
- 11. Existing trading hour restrictions apply.
- 12. Existing licenses (e.g. liquor licenses) still apply.

- 13. Any footway trading cooking food will need to comply with the requirements of the FSANZ Food Standards Code, Food Act 2003 and Food Regulations 2004 which may apply to these types of operations. An application for a temporary food premises registration will be required.
- 14. If your organisation plans to conduct a raffle, you should ensure the raffle complies with the rules and regulations of the Office of Liquor, Gaming and Racing. Call 02 9995 0300 or visit www.olgr.nsw.gov.au.
- 15. Loudspeakers, microphones, and other sound projection equipment must **not** be used without prior Bayside Council approval.
- 16. The instructions of Council's Inspectors, Officers, and the Police are to be strictly adhered to.
- 17. Council reserves the right to refuse any application received.
- 18. Council reserves the right to cancel such permissions granted at any time.

# **FAQ**

## What is an "Extended Trading Area"?

A zone designated by Council on Bay St between Moate Ave and The Grand Parade where the business can trade. The area is directly outside of the business that applies.

#### Who can apply for an Extended Trading Area?

Businesses with frontage onto Bay St between Moate Ave and The Grand Parade are eligible to apply for an Extended Trading Area.

#### What is an "Activation Area"?

A designated zone where business can trade within the closed area of Bay St. Boundaries of the zone will be designated by Council, at their discretion.

#### Who can apply for an Activation Area?

- Businesses with frontage onto The Grand Parade, between The Boulevarde and Princess St
- Businesses with frontage on Bay St outside of the closed area
- Market Stalls
- Other nearby businesses
